1. Background

A assistance to the beneficiary will be provided under the programmes towards procurement and utilization of (i) GRADE-1 BLEACHING POWDER - BIS & ISO- CERTIFIED, (ii) SILKWORM REARING SURFACE DISINFECTANTS/BED DISINFECTANTS (iii) SILKWORM REARING CURATIVES, (iv) UZICIDES that are DEVELOPED BY THE STATE/CENTRAL

SERICULTURAL RESEARCH INSTITUTE/S LICENSED AND CERTIFIED FOR COMMERCIAL PRODUCTION for harvesting successful cocoon crops.

Only such of the BIS & ISO- CERTIFIED GRADE-1 BLEACHING POWDER and SERICULTURAL RESEARCH INSTITUTE/S LICENSED, CERTIFIED SILKWORM REARING SURFACE/BED DISINFECTANTS, SILKWORM REARING CURATIVES & UZICIDES material products as certified by the Sericulture Research Institutes Located in Karnataka state are considered for assistance in order to control the Silkworm diseases and pests.

In view of the above, The Department of sericulture Govt. of Karnataka intending to empanel **only** the

- 3. SERICULTURAL RESEARCH INSTITUTE/S LICENSED, CERTIFIED SILKWORM REARING UZICIDES MANUFACTURERS
- 4. SERICULTURAL RESEARCH INSTITUTE/S LICENSED, CERTIFIED SILKWORM REARING CURATIVES MANUFACTURERS

Products Not Eligible Or excluded: Any other disinfectant or curative or Uzicide products and which are not developed/licensed/certified by the State /Central Sericultural Research Institutes generally available in the open market or such of the products developed by any individual/s or concerns or associations or industries etc are not eligible and accordingly Excluded from this tender.

Validity and Operation: The tenders are valid until 31-03-2021. The Schemes shall be implemented throughout the Karnataka State subject to funds availability.

Objective: To educate sericulture farmers in usage of Grade-1 Bleaching Powder, General & Bed Disinfectants and curatives, that are developed and certified by the State and Central Sericultural Research Institutes, for maintaining hygiene in silkworm rearing so as to control

diseases and pests to increase the production and productivity of quality cocoons and to increase the production of International gradable silk yarn.

1.1 QUALIFICATION AND ELIGIBILITY OF THE MANUFACTURER/S;

- 1.2.1 In case of Grade I Bleaching Powder Only the BIS & ISO-CERTIFIED GRADE-1 BLEACHING POWDER MANUFACTURER/S are eligible to participate
- 1.2.2 In case of Silkworm Rearing Surface/Bed Disinfectants Only the manufacturers with valid licenses from the State or Central SERICULTURAL RESEARCH INSTITUTE/S TO MANUFACTURE THE SERICULTURAL RESEARCH INSTITUTE'S DEVELOPED, LICENSED/CERTIFIED DISINFECTANTS are eligible to participate
- 1.2.3 In case of Silkworm Rearing Uzicides Only the manufacturers with valid licenses from the State or Central SERICULTURAL RESEARCH INSTITUTE'S TO MANUFACTURE THE SERICULTURAL RESEARCH INSTITUTE'S DEVELOPED, LICENSED/CERTIFIED UZICIDES are eligible to participate
- 1.2.4 In case of Silkworm Rearing Curatives Only the manufacturers with valid licenses from the State or Central SERICULTURAL RESEARCH INSTITUTE'S TO MANUFACTURE THE SERICULTURAL RESEARCH INSTITUTE'S DEVELOPED, LICENSED/CERTIFIED CURATIVES are eligible to participate
- 1.2.5 The manufacturers who have valid patent/License/certification or test reports or recommended by the various State or Central Sericulture Research Institutes located in Karnataka state where they Performs all the manufacturing and processing operations needed to produce the products material processing, blending, formulating, filling, packing, labeling and quality testing are eligible to submit e-tenders.
- 1.2.6 In case of Grade I Bleaching Powder Only BIS & ISO Certified manufacturer having valid manufacturing licenses issued by the competent authority, for commercial production are eligible to submit e-tenders.

- 1.2.7 Additionally Manufacturers should be possessing valid License issued from pollution control board/ industrial regulation board/ authority/ department/ SSI.
- 1.2.8 The annual average turnover of the manufacturer for each of the last three years pertaining to their product supply i.e. 2016-17, 2017-18 & 2018-19 should be minimum of Rs. Rs.50.00 lakhs (Please attach audited balance sheet for last 3 years i.e. 2016-17, 2017-18 & 2018-19).
- 1.2.9 Manufacturers having valid GST and PAN Registration certificate.

1.3 General conditions:

- 1.3.1 The Tender shall be submitted only if the Manufacturer is agreeable to all the Terms and Conditions of this Tender notification, which includes the Description and Specifications of the Items mentioned herein.
- 1.3.2 Manufacturers have to submit all the relevant documents/papers with Technical Bid through e-portal only.
- 1.3.3 Non submission of the documents may attract disqualification
- 1.3.4 Only the terms and conditions specified in this tender shall be binding and no other terms and conditions if any specified by the manufacturer shall be binding on the purchaser.
- 1.3.5 The manufacturers shall furnish Letter of Power of Attorney in favour of the person who would deal with Department Of Sericulture.
- 1.3.6 The manufacturers shall quote the rates as per the schedule indicated in Annexure-I.
- 1.3.7 If any technical or administrative problems arise in any of the scheduled components, the particular only such of the schedules will be rejected from the tender process and rest shall be continued.
- 1.3.8 The Manufacturers are strictly not permitted to change any specification Contrary to the rates offered and any such changes at any stage of the tender process and currency shall not be considered.
- 1.3.9 The Manufacturer or his authorized GPA holder shall duly sign Annexure II & III. The name and particulars of the person/s shall

be indicated in Block Letters (Capital) with date and the official seal of the firm or the company

3. MODE OF SUBMITTING TENDER:

- 3.1 Two cover system of tendering as provided under KTPP Act 1999 & rules 2000
- 3.2 The Manufacturer shall submit **Technical Bid** and **Financial Bid** of the tender separately through E-Portal as required/indicated in paras 4 & 5 of this document.
- 3.3 Financial bid of only such manufacturers technically qualified shall be opened
- 3.4 The Tender documents may be downloaded from the e-procurement website https://eproc.karnataka.gov.in & manufacturer shall submit the tender in the manner described hereunder & all the required documents shall be up loaded to the website https://eproc.karnataka.gov.in

4. Earnest Money Deposit (EMD):

- 4.1 Rs.1,00,000/- (Rupees One Lakh only) for each item mentioned in Annexure –I as refundable Earnest Money Deposit in favour of e-procurement, Government of Karnataka.
- 4.2 The EMD and tender processing fee shall be submitted through eprocurement following any one of the four modes; (a) Direct Debit, (b)Credit Card, (c) OTC (Over the Counter), (d)NEFT(National Electronic Fund Transfer)
- 4.3 The EMD will be returned after finalization of the tender process

5. THE 'TECHNICAL BID' SHALL CONTAIN DOCUMENTS LISTED HEREUNDER & SUBMITTED THROUGH E-PROCUREMENT PORTAL.

- 5.1 Registration particulars of the manufacturing concern
 - i. If Proprietorship concern -Registration under Shop & Establishment Act.
 - ii. If Partnership Firm Partnership Deed along with certificate of Registrar of Firms.
 - iii. If Company Memorandum & articles of Association along with incorporation certificate.
 - iv. If others Certificate issued by competent statutory body.
- 5.2 Further, they shall furnish full particulars of postal Address, email, telephone and fax numbers; they shall also indicate the contact details of the authorized persons / agent who shall liaison with the Sericulture Department.
- 5.3 Copy of Income Tax Permanent Account Number (PAN) Card.
- 5.4 GST Registration Certificate and sale tax clearance certificate for the last three years ie 2016-17, 2017-18 & 2018-19
- 5.5 Balance Sheet & Profit/ Loss account statement for the last three years ie., 2016-17, 2017-18 & 2018-19
- 5.6 Copy of valid and active manufacturing license with date of license, stating manufacturing capacity of the unit obtained under the Factory Act.
- 5.7 No objection Certificate issued by the concerned Pollution Control Board where Factory is situated
- 5.8 **Duly attested original BIS & ISO** certification copies shall be enclosed for Grade-1 bleaching powder.
- 5.9 The manufacturer shall submit attested copy of valid SSI certificate issued by Director of Industries
- 5.10 Certificates regarding good management practices issued by accredited agencies
- 5.11 State / Central Sericulture Research Institutes License/ patent/ certification/ test reports to be uploaded separately by the manufacturers:
 - a) For each of the Silkworm Rearing Surface /Bed Disinfectants /Uzicide/ Curatives, products quoted

5.12 Product usage:

- a) The manufacturers shall upload the recommended particulars of the product and usage manual as approved and recommended by the respective Sericulture Research Institutes that have developed/tested the products. Furnish all particulars in Annexure –III and upload as duly signed format
- b) Any documents that are not amenable for uploading on eportal may be furnished as manual submissions duly indicating the details as may be necessary.
- 5.13 Recommended Dosage or Quantity of the Disinfectant material by the Sericulture research Institutes:
 - a) For Grade I Bleaching Powder the Tender participant shall indicate the Dosage or Quantity of the product required to prepare 100 liters of ready to use solution 2 to 5 %
 - b) For Surface Disinfectants the Tender participant shall indicate the Dosage or Quantity of the product required to prepare 100 liters of ready to use solution
 - c) For Bed Disinfectants and Curative formations the manufacturers shall indicate the quantity of material required to rear 100 dfls Bivoltine Hybrid and Cross Breed Silkworms separately from chawki to spinning stage.

5.14 Standards, specifications & packing for grade –I bleaching powder: 5.14.1 Standards & specifications;

- 1. The Grade-1 Bleaching Powder supplied shall conform to the Quality Standards including the standards specified for packing materials under ISI Standard or the purchasers' standard as the case may be
- 2. Stable bleaching powder shall be manufactured as per the Standard No.IS1065:1989. The characteristics are indicated below for ready reference.

<u>CHARACTERISTICS</u>	<u>GRADE I</u>
1. Available chlorine, percent by mass, Min	34.0
2.Stability, loss of chlorine on the basis of initial available chlorine, Max	1/15
3. Moisture, percent by mass, Max	0.3
4. Particle size (passing through 1.70 mm IS sieve) percent by mass, Min	99.5

- 3. Stable bleaching powder shall be white to slightly yellowish-white in appearance and shall be free from hard lumps and any visible impurities. The material shall be dry and free-flowing.
- 4. The material shall comply with the minimum available chlorine content for not less than 30 days from the date of manufacture which should be specified on the container.
- 5. Each consignment of supply of Grade 1 Bleaching Powder shall be accompanied by Report of Tests and Analysis of batch / batches from authorized laboratories. Supplies, without test Report / Reports of the Tests and Analysis each batch, will be rejected and will be deemed as "Not Supplied" even if the consignment has left in the premises of the Purchaser for whatsoever reason.

5.14.2 Packing

The Grade - 1 Bleaching Powder shall be packed in the laminated HDPE bags having 2 inner liners and stitched at the mouth of each inner bag separately with nylon rope and then the outer laminated HDPE woven sack is stitched using polypropylene twisted thread with 2 rows — each row being done separately — one being above the other for the protection during transit. The packages used shall be free from dirt or other foreign materials which are likely to cause decomposition of stable bleaching powder and it should be supplied in packets of 5 Kg & 10kg only. The cover should contain the information in printed form given in ANNEXURE VII.

6 Production Particulars/Details:

- 6.1 Quantity of material delivered to various customers in last three years shall be uploaded as a **market standing**.
- 6.2Details of the R & D Facilities & support of the manufacturing unit shall be uploaded/furnished
- 6.3Copy of quality control and inspection/analysis report from State or Central Sericulture Research Institutes shall be uploaded/furnished for all products other than Grade I Bleaching Powder
- 6.4In case of Grade I Bleaching Powder BIS & ISO certificates with validity period until 31-03-2021 shall be uploaded/ furnished

- 6.5 Details about sales of Grade I Bleaching Powder and that of disinfectant/s, Curatives, Uzicides, for the last three years certified by Chartered Account (2016-17, 2017-18 & 2018-19) shall be uploaded/ furnished
- 6.6 List of Users / Customers served/ supplied material with contact details shall be uploaded/ furnished
- 6.7Manufacturer shall upload/furnish the latest performance certificates issued by the concerned competent authorities who have received the respective products during the previous year's duly recording their opinion on quality and timely supply etc.,

Note: The Tenderer shall submit a hard copy of the uploaded documents before last date for submission

- Based on the above Technical Qualifications shall be evaluated by a Committee as per weightage norms furnished in Annexure-V. Minimum qualifying marks shall be 75.
- The criteria mentioned at Annexure-V with [*] sign are mandatory.
- Annexure-V, group-I minimum mark to be obtained is 08. Unless minimum mark obtained they shall not be considered for further evaluation.
- Financial Bid of only such manufacturers, who satisfies the standard criteria laid down by the Commissioner for Sericultural Development and Director of Sericulture, Bangalore, on the basis of the details furnished in **Technical Bid**, shall be opened.

7. THE 'FINANCIAL BID' SHALL BE SUBMITTED ONLY THROUGH E-PROCUREMENT PORTAL.

- I. The amount per liter/ kg inclusive of GST and other all expenditure shall be quoted in the e-portal **and the same** is considered for finalization. The competent authority will decide to accept the L-1 rate conforming to the specifications.
- II. The Bidders May quote the Rate for all approved products.
- III. The particulars/details of Quantity of Grade I Bleaching Powder and various surface disinfectant products required to prepare 2(%)of 100 ltrs of 'ready to use solution' shall be indicated in Annexure-III
- IV. For bed disinfectants Quantity required to rear 100 dfls BV/CB race in **shoot rearing** method shall be indicated in Annexure-III

- V. For Curative: Dosage for 100Bv/CB dfls rearing as recommended by the Sericultural Research Institutes
- VI. Uzicides: Dosage for 100Bv/CB dfls rearing as recommended by the Sericultural Research Institutes

8. FORFEITURE OF EARNEST MONEY/SECURITY DEPOSIT:

If any of the Manufacturer/s, subsequently withdraws any of the offer/tender or refuse to supply at the offered Price rate, or makes any modification/alteration unilaterally after tender opening, the Earnest Money Deposit shall be forfeited. Similarly if any of the furnished document/s is found fabricated/not factual/manipulated or false in such cases also the EMD shall be forfeited.

9. EVALUATION OF TECHNICAL BID AND OPENING OF COMMERCIAL BID:

- a. Evaluation of technical bids submitted shall be under taken by a technical committee appointed by the Commissioner For Sericultural Development And Director Of Sericulture for this specific purpose
- b. However, evaluation of technical bids of only such manufacturers who have fully furnished /uploaded latest up to date documents as required in paras 4,5 and 6 of this document only shall be considered
- c. Evaluation shall be in accordance with the criteria fixed as in Annexure-IV
- d. Minimum qualifying marks shall be 75
- e. Particulars of manufacturers qualifying technical bids shall be notified by the tender inviting authority

The Commercial bid of only those manufacturers who have qualified in accordance with the technical bid evaluation criteria shall be opened by the tender inviting authority.

10. **VALIDITY OF TENDER:**

i) The tender must be valid for a period of at least 90 days for acceptance from the date of opening of the Commercial bid and it may be extended up to 30 days through mutual consent.

ii) The accepted price rate / offer shall be valid until 31-03-2021 from date of signing the agreement unless extended by the empowered Authority.

11. ACCEPTANCE OF TENDER:

- i) The Commissioner for sericulture Development & Director of Sericulture reserves the right to accept or reject any offer/ tender either in whole or in part irrespective of whether it is lowest or not without assigning any reason whatsoever.
- **ii)** The Commissioner for sericulture Development & Director of Sericulture also reserves its right to select one or more suppliers and award contract for whole or part of its requirement.
- **iii)** The Commissioner for sericulture Development & Director of Sericulture reserves its right to negotiate or seek clarifications before accepting any offer/tender.

12. SUCCESSFUL MANUFACTURER:

- i) The successful manufacturers shall be intimated on the outcome of tender process in writing before the expiry of tender validity.
- **ii)** The manufacturer shall respond within seven days from the date of receipt of above intimation of their acceptance or otherwise.
- **iii)** If letter of acceptance does not reach with in specified period above, tender inviting authority shall not be held liable and, shall have right to forfeit Earnest Money Deposit.
- **iv)** If the manufacturer(s) who is/are invited (if occasion so requires) for negotiations do not remain present during negotiations, their original tendered rate shall not be taken into cognizance.
- v) The successful manufacturer shall be required to furnish SECURITY DEPOSIT of Rs.2.00 lakh for each of the products in the form of irrevocable Bank Guarantee in favor of the Commissioner for Sericultural Development and Director of Sericulture, Bangalore 560001, payable at Bangalore, issued by any nationalized banks having official branch in Bangalore.

13. Agreement:

The successful empanelled manufactures shall execute a Contract /Agreement on Karnataka Government Non- judicial Stamp Paper in duplicate of the face value of Rs.200.00 (Rupees two Hundred Only – cost to be borne by the manufactures) as provided by Article 5 of the

schedule of Karnataka Stamp Act. A copy of the contract agreement shall be provided to such of the manufacturer. The Specimen form of agreement is available with the CSD & DOS and same shall be provided along with letter of intimation. Completed tender agreement to be duly executed within 15 days from the date of letter as furnished above with security deposit.

14. PURCHASE ORDER AND SUPPLY:

- i) The functionaries DDS, ADS, SEOs at Dist, taluka and Technical service centre (TSC) level may place the purchase order
- ii) The various beneficiaries of the programmes of Sericulture Department in Mysore seed, Bivoltine seed areas may place the purchase order
- iii) Sericulturists of Bivoltine clusters, MNREGA beneficiaries and CRC units may place the purchase order
- iv) Officers in charge of Govt. silk farms of may place Orders
- v) All the orders placed by the Sericulture Department official functionaries shall be subject to availability of funds and approval by the competent authority
- vi) The manufacturer shall undertake all supplies strictly as per the terms and conditions and quality norms specified in the agreement
- vii) During the tender validity period the manufacturer shall supply the products adhering to quality and packing norms as laid down on the Agreement to the destination within 15 days from the date of placing orders by the various functionaries/beneficiaries indicated above

15. COMMENCEMENT AND TERMINATION OF ORDER:

- i) It shall be in force until 31-03-2021 from the date of signing the agreement.
- ii) The contract can be terminated on mutual agreement within the agreement period.
- iii)The contract period beyond the above specified period may be extended by the CSD & DOS as per the provisions of the KTPP Act.

16. INSPECTION:

i) The Commissioner for sericulture Development & Director of Sericulture reserves right to inspect finished/packed goods through his subordinate officers at any time from the manufacturer end.

- ii) The samples of the product shall be got tested from the concerned sericultural research institutes who have developed/patented /licensed/ certified the different products and the Grade I Bleaching Powder samples shall be got tested at the laboratories indicated by the Department.
 - iii) Drawing samples from the manufacturing unit/factory, quality verification at notified laboratory and whatever expenses incurred shall be borne by the manufacturer.
- viii) The manufacturer shall clearly indicate the content of the product on the packages
- ix) If sample/product does not confirm to the specification of material, The Commissioner for Sericulture Development & Director of Sericulture have right to terminate the contract and payments outstanding and also the EMD and the Security deposit shall be forfeited.
- x) All the supplies shall have to take back once the products are rejected at the risk and cost of such of the manufacturer/s.

17. GUARANTEE:

- i) All the supplies shall be guaranteed against manufacturing defects and against unsatisfactory performance for a period of one year from the date of supply.
- ii) During the period of guarantee, if any of the stipulated guarantee is not attained, i.e. quality, quantity, performance, efficiency, etc. the manufacturer shall have to replace the defective material as may be required to fulfill the guarantee requirements, free of cost, immediately but not later than 15 days from such intimation by any of the authorised representative of The Commissioner for Sericulture Development & Director of Sericulture.

18. PAYMENT:

Payment shall be only against physical delivery of the products indented and after obtaining test certificates from the concerned Sericultural research institutes who have patented /licensed/certified the various products or the laboratories indicated by the Department. Payments shall be subject to availability funds, through a treasury cheque, within 45 days from the date of receipt of the indented supplies. The concerned district officer/s of the Sericulture

Department shall facilitate the payment of beneficiary oriented programmes for which the Departmental Officers may have placed written supply indents.

Any private individual indents including Bivoltine sericulture Farmers, Chawki Rearing Centers and MNREGA beneficiaries shall directly clear their payments and Department of Sericulture shall not be liable on such payment lapses.

19. PENALTY /BLACK LISTING:

- i)For breach of any of the conditions of the agreement the Commissioner for Sericultural Development and Director of Sericulture, Bangalore may impose a penalty based on the gravity of the lapse and may also Black List.
- ii) Failure to supply within the stipulated time and the approved quantity the Commissioner for Sericultural Development and Director of Sericulture, Bangalore may impose the penalty of 10% value of each of the order.
- iii)For the above lapse, the successful manufacturer shall be BLACKLISTED and notified as DEFAULTER prohibiting him from participating in any of the future tenders of the Department for period of 2 years.
- iv) Any of the penalty imposed may be recovered/collected from the Security Deposit any penalty over and above the Security Deposit such manufacturer shall be liable.

20. FORCE MAJEURE:

The Commissioner for Sericulture Development & Director of Sericulture or his authorised representative/s, shall in any way not be held liable on any failures on their part or to make good any loss or damage to the successful manufacturer/s owing to any of the causes of natural disaster including the situations brought by the workers / labourers or transport, riot, civil commotion, accident or any unforeseen event or any other cause whatsoever, beyond their control.

21 ARBITRATION AND LEGAL JURISDICTION: Any dispute arising under the contract shall be subject to the jurisdiction of Bangalore city courts only. However, disputes in all matters arising out of related contract, shall be settled by the sole arbitration of The Commissioner

for sericulture Development & Director of Sericulture. The decision of the Commissioner for Sericulture Development & Director of Sericulture acting as an Arbitrator shall be final and binding on both the parties.

- **22.** After opening the tender, The Commissioner for sericulture Development & Director of Sericulture shall be at liberty to follow any of the 2 procedures for award of the tenders.
 - i) Finalize the tenders without any negotiation.
 - ii) Call the bidders for negotiation.

It shall be the absolute discretion of The Commissioner for Sericulture Development & Director of Sericulture to follow any of the above modes to accept the bids. It shall also be the absolute discretion of The Commissioner for Sericulture Development & Director of Sericulture not to accept any of the bids.

23. SAVING CLAUSE: Protection Of Action Taken In Good Faith, No suit, prosecution or any legal proceedings shall lie against the Commissioner for Sericultural Development and Director of Sericulture, Bangalore or his authorized representatives for anything which is done in good faith or intended to be done in pursuance of this Tender including the tendered quantity of the items notified.
